A. EXTENSION OF DEADLINE FOR PROJECT ABSTRACT SUBMISSION

1. In consideration of industry feedback, the current **deadline for the Project Abstract submission** will be extended from 9 October 2015 to **6 November 2015, 5pm** with immediate effect. This is to allow health/social care providers and solutions providers more time to facilitate the formation of partnerships and discussions for the submission.
2. For the avoidance of doubt, Team Leads of Project teams shall still submit two (2) hardcopies of the Project Abstract and any supporting documents to MOH by the new deadline of **6 November 2015, 5pm** to the following address:

4. Consequentially, the **deadline for the submission of the detailed project proposal** will also be postponed to **January 2016**. Project teams whose Project Abstracts have been shortlisted for the second Detailed Project Proposal submission stage will be informed of

B. AMENDMENTS TO IP POLICY FOR CARE-AT-HOME INNOVATION GRANT

1. With consideration to industry feedback, the following amendment will be made to Clause 3.3 under Section 3, *Ownership of Documents and Intellectual Property* of Annex A to the Care-at-Home Innovation Grant Public Document with immediate effect.

3.3 *In consideration of MOH agreeing to the vesting of the Foreground IP in the Awardee, the Awardee shall grant to MOH and MOH's Affiliates, free of any additional charge, the following licenses:*

3.3.1 *an irrevocable, perpetual, ~~worldwide~~ Singapore, non-exclusive, royalty-free licence to reproduce, modify or use any Background IP (together with any modifications, improvements and developments thereof, which shall be promptly communicated to MOH) owned by or licensed to the Awardee, its subcontractor or supplier; and*

3.3.2 *an irrevocable perpetual, ~~worldwide~~ Singapore, non-exclusive, royalty-free licence to reproduce, modify or use any Foreground IP (together with any modifications, improvements and developments thereof, which shall be promptly communicated to MOH) which is or becomes vested in the Awardee, its subcontractor or supplier.*
